- Open to all current members of VWS.

- All work must be original and of the artist's own resource. Work done under supervision of an instructor or in a class/workshop is ineligible.
- Work must be created with acceptable water-soluble mediums per VWS guidelines.
- Framing must meet VWS guidelines. These can be found on the website under the Member Resources tab.
- Due to the hanging system in the gallery, there is a minimum frame size of 16" in any direction. There is no maximum limitation.
- The juried show counts towards signature status.

- \$15 entry fee for 1 or 2 entries. Both entries can be accepted to hang in the show.
